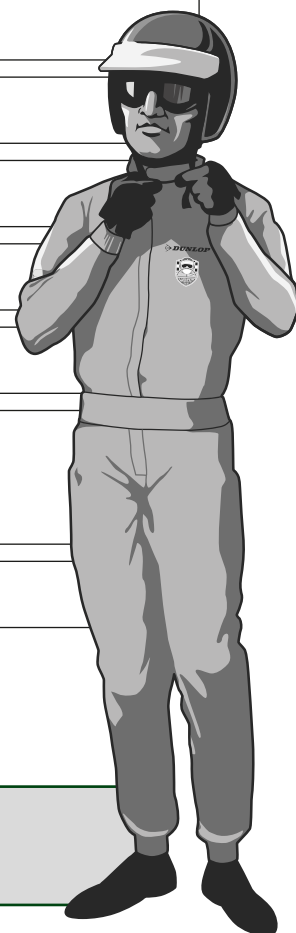

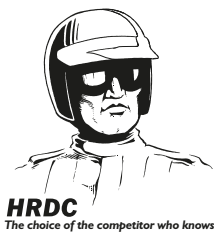

# TERMS OF MEMBERSHIP 2024

## SPORTING REGULATIONS

- HRDC Ltd is a Private Limited Company registered No: 06501745
- HRDC Ltd operates a variety of Historic Race Series, to which entry is strictly by invitation only, in 30-minute, 1-driver format and 45-minute, optional 1 or 2-driver format, with the latter having a compulsory pit stop between 15 and 30 minutes. Other formats may apply to individual race events subject to the track time availability offered at the corresponding venue.
- All Series and Sporting regulations must be treated in the spirit of the sporting code of conduct that is upheld at all HRDC events.
- Competitors are encouraged to embrace the presentation of the era in which their cars race originally competed. This applies to the appearance and detail of their race cars, race apparel and that of their team.
- Unsporting behaviour, both on and off the track, will be deemed by the HRDC as unacceptable and will result in the withdrawal of future invitations to race. Membership fees will not be refunded.
- All queries or disputes involving these regulations and the application of such must be addressed in writing only to the HRDC. The HRDC's ruling will be deemed as final.

## MEMBERSHIP & FEES

- Membership fees are deemed as a donation to the running of the HRDC. They are not refundable.
- Competitors who have paid the HRDC annual Membership fee will be informed in advance of races and will receive entry forms to those events, which by doing so, will act as an invitation to race at that event provided that the competitor in question complies in full with the terms of invitation and that space is available to race at the event in question.
- All entries so received are subject to the HRDC's final decision and are not automatic.
- All Members of the HRDC are bound by these terms and conditions.
- The HRDC reserves the right to refuse Membership and/or revoke such Membership should any of the terms of agreement been deemed in violation of such by the party in question.

## ENTRY FEES

- Entry for each race is strictly by invitation.
- Applicants must be Members of the HRDC. All entries must be accompanied by full payment for the race applied for. Entry forms received without payment and/or from non-Members will be deemed null and void until all payments due are paid in full
- All entry fees accepted by the HRDC are deemed strictly as an 'Option to Race'. Such entries are transferable should the applicant find himself / herself unable to race at the event in question. Such transfers must be carried out only with the prior express permission of the HRDC in writing no later than 10 working days prior to the event in question. Transferees must be approved prior to transfer by the HRDC and comply with the HRDC terms of application and Membership. Transfers can only be made for the event in question and will not be valid for future events.

## REFUNDS

- Should a race or race meeting have to be cancelled due to circumstances beyond the control of the HRDC, however cause or deemed by the party cancelling the event in question, ('Force Majeure') the HRDC reserves the right to reschedule the race or race meeting. In the event that this is not possible competitors will be entitled to a refund not exceeding 20% of the entry fee(s) they have paid.
